Donald Trump is shredding the U.S. Constitution and the rule of law with stunning speed and ruthlessness — and the Supreme Court's right-wing supermajority is helping him every step of the way.

Time and again, lower federal courts have blocked Trump's most flagrantly illegal actions only to have Clarence Thomas, Samuel Alito, and the rest of the far-right majority overrule them with unsigned, unexplained "emergency" orders.¹

These are the very same justices who have pocketed millions in gifts and payouts from MAGA megadonors and corporate law firms — and they must be held accountable before they dismantle what's left of our democracy.²

Rep. Alexandria Ocasio-Cortez filed formal articles of impeachment against Justices Thomas and Alito during the last Congress, and now is the time for action.³

Last week, the Supreme Court overruled a lower court to allow federal immigration agents to engage in flagrant, systematic racial profiling in defiance of the Fourth Amendment and decades of the Court's own precedent.⁴

It was just the latest example of the Supreme Court justices stepping in to green-light Donald Trump's lawless authoritarian rampage.

The justices overruled lower courts to allow Trump to deport immigrants to El Salvador's infamous CECOT prison with no due process.⁵ They gutted protections for public workers and independent agencies, allowing Trump to fire tens of thousands of federal employees and agency heads without cause and replace them with MAGA stooges.^{6,7}

They've overturned Bush appointees, Obama appointees, and even Trump appointees. And perhaps worst of all, they overruled the lower courts to give Trump near-total immunity from prosecution for crimes committed while in

office.⁸

All this comes after the justices have cashed in on sweetheart real estate deals, luxury vacations, travel on private jets and mega-yachts, and more — paid for by right-wing billionaires like Harlan Crow and executives at corporate law firms with business before the Court.⁹

This is corruption, pure and simple, and it's paving the way for Trump's authoritarian assault on democracy.

Demand Progress Action has mobilized tens of thousands of people to Alexandria Ocasio-Cortez's call for the impeachment of Justices Thomas and Alito. Now with the survival of democracy on the line, we must ramp it up.
