Last week, House Democrats released the infamous letter from Trump to Epstein from his birthday book. In the alleged note, Trump says that he and Epstein share a "wonderful secret." 1

"Refusing to release the files erodes public trust and faith in our institutions," said Rep. Ro Khanna, who is leading a discharge petition with Rep. Thomas Massie to force a vote on releasing the Epstein Files.³ The measure has bipartisan support and is close to reaching the 218 member majority that would require Speaker Johnson to hold a vote on finally answering the calls of survivors, advocates, and the public.

Rep. Khanna also said that, "the government has chosen to protect Epstein and the well connected over children who were being abused."⁴
